FLORES, CESO II, herein referred to as "NNC"; and

The UNIVERSITY OF THE PHILIPPINES LOS BAÑOS FOUNDATION, INC. a non-stock, non-profit corporation duly registered with the Securities and Exchange Commission with office address at UPLBFI Bldg., A. Aglibut Avenue, University of the Philippines Los Baños, College, Laguna represented herein by its Executive Director DR. CASIANO S. ABRIGO, JR. herein referred to as "UPLBFI".

#### WITNESSETH

WHEREAS, the NNC was given oversight function to lead and coordinate the implementation of the Promote Good Nutrition (PGN) component of the Accelerated Hunger-Mitigation Program (AHMP) in 2007 which included a training component;

WHEREAS, considering the trainings were a major component of the PGN program that was provided with substantive resources, the NNC intends to hire the services of a consultancy group to conduct the Summative Evaluation of the Training on the Promote Good Nutrition Program;

WHEREAS, the NNC Bids and Awards Committee (BAC), through BAC Resolution No. 018-2017 hereto attached as Annex 1 which is an integral part of this contract, recommended the hiring of UPLBFI after public bidding to undertake the project;

WHEREAS, UPLBFI, expressed its interest to undertake the project;

**NOW THEREFORE**, for and in consideration of the foregoing premises hereinafter stipulated, the parties have agreed as follows:

1. The UPLB FOUNDATION, INC. shall perform the tasks required for the Summative Evaluation of the Training on the Promote Good Nutrition Program as indicated in the Terms of Reference hereto attached as Annex 2 and is made an integral part of this contract.

# 2. NATIONAL NUTRITION COUNCIL shall:

- a. perform the functions as per Terms of Reference (Annex 2); and
- b. process payment to the contractor upon receipt of the required deliverables.

## 3. PROJECT COST and TERMS OF PAYMENT

The total project cost is Php999,983.00, charged against the A.III.d funds of NNC, subject to usual government accounting and auditing rules and regulations.

The consultant shall be paid through domestic letter of credit (LC), upon presentation of certificate of acceptance from NNC which shall be based upon submission of required deliverables for each tranche of payment as follows:

# 6. **DURATION AND EFFECTIVITY**

This Contract shall take effect upon the issuance of the Notice to Proceed by the NNC and shall remain in force for a period of one year, unless otherwise modified or amended by mutual written consent of parties concerned. Provisions of this Contract may be modified, altered, supplemented or amended subject to the mutual written agreement of both parties which can be in a form of letters of conforme.

# 7. OWNERSHIP

All soft and hard copies of documents, reports, tools and materials developed and submitted by UPLBFI shall be the property of the NNC. The consultant will not have any rights to copy, retain, reproduce, or use the documents, reports, tools and materials without written approval of the NNC. The report shall be confidential unless otherwise stated by the NNC.

# NO EMPLOYER-EMPLOYEE RELATIONSHIP

Nothing in this Contract shall be construed as creating an employeremployee relationship between the NNC and UPLB, its sub-contractors, employees, agents or workers.

#### 9. **PENALTY**

This Contract shall be implemented as agreed upon in accordance with the terms and conditions stipulated herein. Failure on the part of UPLBFI to comply with the provisions of this Contract shall be cause for the imposition of appropriate penalties and/or the contract's termination.

A penalty of one tenth of one per cent of the undelivered amount of the total project cost will be deducted from the final payment for every day of delay in the implementation of the project for causes attributable to UPLBFI. However, in the event where work is delayed due to delays in the approval of the documents by NNC or other reasons beyond the control of UPLBFI, both parties shall mutually concur and agree in writing on a revised schedule or workplan.

In the case of termination of the Contract prior to its expiration for causes attributable to UPLBFI, the NNC has the right to confiscate its performance security. NNC will also recommend UPLBFI for blacklisting and shall be paid on a *quantum meruit* basis.

#### 10. **VENUE**

In case of disputes arising from the interpretation or implementation of this Contract, the courts of Taguig City shall have exclusive jurisdiction to the exclusion of all other courts.
